STRATEGIC PLANNING SESSION

This month of February 2021, we held several strategic sessions with CEOs and their respective teams to collaborate on the development and implementation of a plan to organizational development.

These sessions were characterized by:

- Reflections on the mission, vision, and culture of the company,
- Strengths, Weaknesses, Opportunities, and Threats analysis SWOT analysis,
- BCG analysis: strategic classification of products and services according to their profitability for the company (relative market share) and their investment needs (growth rate in the market),
- Stakeholder mapping,
- Market analysis: customer needs and characteristics, competition, risks,
- PESTEL analysis: the macro-environmental factors that can affect the company Political, Economic, Sociological, Technological, Environmental, and Legal aspects.

MENTORING PROGRAM

Working toward good corporate governance and capacity building, BiD has decided to develop a mentoring program to support and strengthen its coaching system. As a result, we have identified business leaders who are committed to good corporate governance and continue to distinguish themselves in their sectors of activity.
